#### Notification

**Subject: District Municipal Commissioners.**

The Governor of Haryana is pleased to direct that some of the powers vested in Deputy Commissioners of the districts in respect of Municipal Councils & Municipal Committees falling in their respective jurisdiction under the Haryana Municipal Act, 1973 and Rules/Bye-Laws made therein be entrusted to newly created post of District Municipal Commissioner with immediate effect in terms of this notification.

**2. Appointment of District Municipal Commissioners**

Subject to the provisions of this notification, District Municipal Commissioners shall be appointed by the Government.

**3. Jurisdiction of District Municipal Commissioners**

In all the districts (except Charkhidadri and Faridabad) a District Municipal Commissioner each shall be posted. Charkhidadri district shall be clubbed with Bhiwani district. The jurisdiction of these newly created/designated posts of District Municipal Commissioners shall be as below:

#### 4. Responsibilities of District Municipal Commissioners

The Powers and Responsibilities of the District Municipal Commissioners shall be as under: -

- i. To exercise all the powers of the Deputy Commissioner as included in the delegation order appended as Annexure-1 of this Notification.
- ii. Superintendence, control and monitoring of the Municipal bodies falling under their jurisdiction.
- iii. Co-ordination with the District Administration as well as the other Line Departments/offices for implementation of the Government policies/schemes.
- iv. Supervision of Implementation of Centrally Sponsored Schemes as well as State Government Schemes or programs, projects and other activities etc. entrusted to the Municipal Bodies.
- v. To take cognizance directly on the matters/complaints against officers/officials of the respective Municipalities as ex-officio Chief Vigilance Officer.
- vi. Remarks on the ACRs of the officers/officials of respective Municipalities (detailed circular will be issued later).
- vii. Any other power delegated/ responsibilities assigned by the Government.

**5. Financial Powers of District Municipal Commissioners**

District Municipal Commissioner shall be the Head of Office and shall exercise all such financial powers relating to Municipal Councils & Municipal Committees under his/her jurisdiction in the respective district.

They are empowered to sanction the developmental works/projects upto Rs. 50.00 lakhs for each work/project and rate approval upto Rs. 50.00 lakhs in respect of Municipal Councils & Municipal Committees falling in their respective jurisdiction. They shall forward the cases amounting to more than Rs. 50.00 lakhs to Director, Urban Local Bodies Department with their recommendation.

**6. Administrative Control**

The District Municipal Commissioners shall work under the immediate administrative control of Director Urban Local Bodies, Haryana.

**7. Annual Confidential Report**

The Director General, Urban Local Bodies and Administrative Secretary to the Government of Haryana, Urban Local Bodies shall be the initiating authority, Urban Local Bodies Minister shall be reviewing and Chief Minister Haryana shall be accepting authority for the Annual Confidential Report of all the District Municipal Commissioners.

**8. Vacancy of District Municipal Commissioner**

Deputy Commissioner of the district shall automatically exercise all the powers and discharged all responsibilities of District Municipal Commissioner as and when the post of District Municipal Commissioner falls/remains vacant.

**9. Entitlement & Establishment Expenses**

District Municipal Commissioners shall be entitled to take a car on hire basis. Their salaries, perks & other establishment expenses shall be borne completely by the State Government, for which orders shall be issued separately.
