**Subject:- Regarding implementation of Internet Based Electronic tendering system in the Municipalities of the State.**

Reference to this department memo No. DULB/St.A/2014/54402-80 on the subject noted above.

2. It is to inform you that vide letter dated 20.11.2014, the Government has decided to enforce the Internet Based electronic tendering system for all types of works whether procurement of civil works, purchase of stores or engagement of labour through outsourcing policy for any cost with effect from 01.12.2014 on NIC portal i.e. e-tenders.hry.nic.in in all the Municipal Corporations/Councils/Committees of Haryana State. But as on 17.12.2014 form the period 01.11.2014 to 17.12.2014, Internet Based Electronic tendering process has been implemented in 43 Municipal Corporations/Councils/Committees of Haryana State, but your municipalities have not adopted this system till now.
3. Therefore, it is again directed to invite all the tenders through Internet Based Electronic tendering system only, otherwise disciplinary action will be taken against erring officers/officials.
