Regarding notification of unauthorized colonies.

It is to inform that the Hon'ble Chief Minister had chaired a meeting on 17.11.2022 to review the progress of unauthorized colonles in the State. During the meeting it was deliberated that the applications from RWA of the respective unauthorized colonies have not been received along with the layout plan as surveyed by the Town & Country Planning Department. It was decided that proper application/ representation from RWA each unauthorized colonies needs to be obtained. It was also discussed that in colonies where the RWA has not been formulated, the officers of concerned municipality will get it constituted and further held the RWA to make the application/representation. In view of the said discussion a preliminary list of 411 colonies is attached with a request of following necessary action:-

I. Each municipality shall constitute a dedicated team with Deputy Municipal Commissioner in case of Municipal Corporation and EO/ Secretary in case of Municipal Council/ Committee. The concerned DTP shall also be a dedicated member of this team. This team shall be functional under the Commissioner / District Municipal Commissioner as he case may be.

II. The Commissioner / District Municipal Commissioner may depute team:-

a. for approaching the RWA of the colonies for receiving the formal representation/ application for notifying the colony, and forward the same to this Department by Monday i.e. 28.11.2022. —

b. To assist in constitution of RWA of 11 members from the colony. The association shall initially be constituted informally by way of affidavit on Rs 100 Stamp paper, followed by its registration. The team shall also receive the formal application from the said RWA and send to this office by Monday i.e. 28.11.2022.

I have been directed to request you to take the above matter on top most priority.
