The meeting started with the welcome of all the participants and deliberated the matter regarding review of the **progress of Compliance of NGT orders and various Waste management Rules 2016.**

1. At the outset, **Sh. R.S.Verma, Commissioner, Municipal Corporation, Rohtak** briefed about the latest position of the waste collection and its disposal in Rohtak. He discussed all the participants on the following points:-

- 1- 100% Door to Door Collection.
- 2- 100% Segregation of waste at source.
- 3- 100% waste processing by bulk waste generator.
- 4- 100% wet waste processing by Hotels/Banquets.
- 5- Bio-medical waste processing.
- 6- Green waste processing.
- 7- C & D waste collection, transportation, processing and identification of site.



- 8- E waste – collection, transportation, processing and identification of Re-cycler of E-waste.
- 9- M.R. facility at solid waste plant.
- 10- Environment clearance of solid waste plant.
- 11- Collection, transportation and disposal of dead animals.
- 12- Collection, transportation and disposal of waste from fruit, vegetable market.
- 13- Slaughtering of animals.

After detailed discussion, he appreciated the efforts and contribution of the residents of Rohtak to achieve 2<sup>nd</sup> position in Haryana State and 69<sup>th</sup> rank in India during Swachh Sarvakshan 2019. He also welcomed the E&Y Representative Ms Ira Singla. Ms. Ira Singla presented the Waste Management's Rules and their existing position. She discussed on the following Waste Management rules:-



2. Sh. R.S.Verma, Commissioner, Municipal Corporation, Rohtak informed that the District Level Committee has been constituted and circulated vide letter no. MCR/Xen(HQ)/2019/62-84 dated 16.3.2019 consisting Mayor, CMO, President of MC-Kalanaur, Sampla & Meham, President of Industries association, GM, HSIIDC, Joint Director, Industries, Rohtak, SE, Public Health Engineering Department, Representative of Gaushalas, President of RWA, EO, HSVP, Secretary of all Market Committee, President Fruit & Vegetable Market, President Market Association, RO, Pollution Control Board Bahadurgarh, Bulk Waste Generator MDU, PGIMS, President Hotel Association, Rohtak, DTP, Town & Country Planning, Rohtak, IMA, President, Rohtak, Divisional Labour Commissioner, Bahadurgarh/Rohtak, Deputy Director Agriculture, Rohtak, Deputy Director, Animal Husbandry, Rohtak for enforcement of the provisions stipulated under the SWM Rules and providing monthly status report. Sh. Manjeet Dahiya, Xen (HQ), M C Rohtak has been appointed as nodal officer.
  3. He also informed that 33.89 acre of land at village Sunaria already identified for setting up solid waste processing facilities and at present 155 MT waste processed and converted into the compost.

6. Chairman also motivated all the paticipants to avoid the use of single use plastic and polythenes.He requested :-

- (i) Plastic waste, which can be recycled, shall be channelized to registered plastic waste recycler and recycling of plastic shall conform to the Indian Standard: IS 14534:1998
- (ii) Encourage the use of plastic waste (preferably the plastic waste which cannot be further recycled) for road construction as per Indian Road Congress guidelines or energy recovery or waste to oil etc.
- (iii) Thermo set plastic waste shall be processed and disposed off as per the guidelines issued from time to time by the Central Pollution Control Board.
- (iv) The inert from recycling or processing facilities of plastic waste shall be disposed of in compliance with the Solid Waste Management Rules
- (v) Development and setting up of infrastructure for segregation, collection, storage, transportation, processing and disposal of the plastic waste
- (vi) Ensuring segregation, collection, storage, transportation, processing and disposal of plastic waste; (b) ensuring channelization of recyclable plastic waste fraction to recyclers; (c) ensuring that open burning of plastic waste does not take place.
- (vii) Minimize generation of plastic waste and segregate plastic waste at source in accordance with the Solid Waste Management Rules, 2016 and handover segregated waste to urban local body
- (viii) All waste generators shall pay such user fee or charge as may be specified in the bye-laws of the local bodies for plastic waste management such as waste collection or operation of the facility thereof, etc.
- (ix) Every person responsible for organising an event in open space, which involves service of food stuff in plastic or multilayered packaging shall segregate and manage the waste generated during such events in accordance with the SWM Rules, 2016 or amendment from time to time.
- (x) The shopkeepers and street vendors willing to provide plastic carry bags for dispensing any commodity shall register with Municipality. The Municipality shall, shall make provisions for such registration on payment of plastic waste management fee of minimum rupees forty eight thousand @ rupees four thousand per month. The registered shop keepers shall display at prominent place that plastic carry bags are given on payment.
- (xi) Only the registered shopkeepers or street vendors shall be eligible to provide plastic carry bags for dispensing the commodities.


